## Guidelines

Students who are doing prerequisite coursework to gain admission to a future program are not eligible for grants, however the student could be loan eligible if they are enrolled in at least 6 credits and meets the following conditions:

- The coursework requested by the student must be documented as required to gain entrance to your future program.
- The student cannot request to re-take any coursework purely to raise their GPA.
- While the student is not required to be in a financial aid eligible program, the coursework must be part of a financial aid eligible program offered at Shoreline, and not designed only to serve as a standalone preparatory course.
- The loan can only be offered once, and for no longer than 12 consecutive months. It cannot be extended past the 12 months under any circumstances.
