Admission Requirements and Procedures for all Nursing Students

Admission is based on a point system (see next page). This same point system also selects alternates for our program. Points are awarded for grades in prerequisite courses and grades in additional college courses taken that meet requirements for program completion and practical preparation.

Applying to the Shoreline Nursing Program

Next application periods for 6 - Qtr & LPN to RN: Jan 15 - Apr 3, Aug 15 - Oct 3, Nov 15 - Jan 10 (every year)

Next application period for part-time 11- Qtr: January 15, 2025 – April 3, 2025 (every other year)

<u>Step #2</u> – After filling out the general college application, then apply to the College's Associate Degree Nursing Program: <u>Start Nursing Program Application</u> A \$20.00 non-refundable processing fee using a credit/debit card will be required.

Transfer of Credit Policy

Shoreline Community College Transfer of Credit policy 5165 may be reviewed <u>HERE</u>. Pre-requisites and other courses outside of Shoreline must match content and credit hours for admission or transfer into the SCC Nursing Program. Courses from Washington 4-year colleges and community colleges in Washington State listed on the <u>Course Equivalency Chart</u> are known to be equivalent and do not require further evaluation. If the course does not appear on the course equivalency chart, you must submit a nursing request for transcript evaluation to determine course equivalency.

For each course you wish to have evaluated, submit a <u>Transcript Evaluation Request Form</u>, an unofficial transcript, and course description or syllabi. Evaluations typically take 3 weeks to complete, and the evaluation will be emailed to the student when completed.

Please Note: Requests submitted with applications will not be evaluated. Please submit requests at least 4 weeks before the application deadline.

International transcripts must be translated into English and evaluated by an official, independent evaluation service. This requires a course-by-course evaluation. Please note that this process may take up to 8-10 weeks. After this evaluation is completed, submit a copy of the evaluation with a nursing request for transcript evaluation. International transcripts do not require course descriptions or syllabi.

Tuition, Fees, and Other Nursing Program Costs

Refund of Costs Policy and Procedures

According to Shoreline Community College policy #3620, Refund of Tuition and Fees, "students shall receive refunds of tuition and fees fairly and equitably per policy expressed in state law. Further, all applicable federal laws and regulations will be observed and implemented when necessary to maintain eligibility for Federal funding of programs, as allowed by State law".

Refunds are made according to the following schedule:

Through the first week of the quarter:

(Summer equivalent = first through fourth days)

• Full 100 percent refund except for fees listed as non-refundable. There will be no record of the class on the student's transcript.

Second week of the quarter:

(Summer equivalent = fifth through seventh days)

• 50 percent refund except for fees listed as non-refundable. There will be no record of the class on the student's record.

Third week of the quarter:

(Summer equivalent = eighth through eleventh days)

• 50 percent refund except for fees listed as non-refundable. The instructor's approval is required to withdraw, and withdrawal will appear on the student transcript as a W.

After the third week of classes

(Summer equivalent = after the eleventh day)

• No refund will be issued.

Please Note: Once instruction has begun, fees for private instruction are not refundable.

Students who withdraw from the college without complying with official withdrawal procedures and students who are asked to withdraw by the college do not receive a refund of fees.

- **Example 1:** Student A officially withdraws during the first week of the quarter. He or she is eligible for a 100% refund.
- **Example 2:** Student B withdraws halfway through the second week of the quarter. Whether or not the student attended class, he or she is eligible for a 50% refund.
- **Example 3:** Student C withdraws on the first day of the fourth week of the quarter. No refund will be issued to the student.

Please Note: Financial Aid recipients should refer to the Conditions of Award.

Financial Aid Opportunities and Requirements

Financial aid helps students pay for college. This financial assistance can cover educational expenses including tuition and fees, books, supplies, and transportation. There are several types of financial aid, including grants, scholarships, work-study, and loans. Financial aid awards may include a combination of these various types of aid.

Federal and State grants, loans, and work-study are awarded through applying for financial aid. Start the process by submitting an FAFSA application to <u>studentaid.gov</u>. Please note that the Federal School Code for Shoreline is **003791**.

Workforce Education

- **Housing Support:** Access funds, navigate emergency housing, and receive other support like rent and utility assistance.

- **Emergency Funds:** Receive money to help with unexpected costs, including transportation, medical, family/household emergencies, food, and childcare expenses.

Grading System and Related Policies

The policy of Shoreline Community College regarding class attendance applies to nursing students. It is the student's responsibility to attend class and, when absent, obtain any missed information from fellow students. You are also responsible for any announcements made in class. Please refer to the policy regarding alternative test-taking time below.

Passing grades (2.0 or better) must be earned in all nursing theory courses. Failure in any one area of a nursing quarter may require repeating all. If satisfactory completion of the course is in jeopardy, the student will be notified as early in the quarter as possible.

Grade Computation

- Students must earn 75% of total testing points (quizzes and final examination) to receive a 2.0 or greater.
- If the total number of testing points is less than 75%, the grade will be based only on the testing percentage.
- If the total test percentage is 75% or greater, additional points for other assignments will be added, and the grade will be based on the percentage of total points earned.
- Bonus points, if earned, will be added if this total grade is 75% or greater.

Student Accessibility Services

Students with documented accommodation for testing with Student Accessibility Services must arrange a testing time with the instructor. New accommodations for testing must be received from Student Accessibility Services 48 hours before the test date. Testing should be arranged simultaneously as other students are testing whenever possible. The instructor must approve different times.

Technical Standards of the Nursing Program

The discipline of nursing requires healthcare providers to perform patient-care tasks that involve the use of the following functional abilities:

Ability to Communicate	• Strength, Mobility, Balance	• Hearing Ability
Olfactory Ability	Physical Endurance	Emotional Stability
Tactile Ability	Visual Acuity	Cognitive Ability

The functional abilities required are essential in the sense that they constitute core components of nursing practice and there is a high probability that negative consequences will result for persons under the care of nurses who fail to demonstrate these abilities. The Shoreline Nursing Program requires students to engage in a variety of laboratory and clinical experiences to acquire essential nursing skills and functions. These standards are reflected in performance-based outcomes of Shoreline's nursing program and are the basis for teaching and evaluating all nursing students. Students wishing to enter the Shoreline Community College Nursing Program must demonstrate that they can meet these technical standards with or without reasonable accommodation and continue to do so throughout their educational program.

Students with disabilities who think they may require accommodation to meet the technical standards of the nursing program should contact Student Accessibility Services (SAS) to discuss the process of identifying reasonable accommodation. Contact with SAS should be done as soon as possible so that a plan for accommodations can be in place at the beginning of the program. Reasonable accommodation will be directed toward providing an equal educational opportunity for students with disabilities while adhering to the standards of nursing practice for all students.

The Nursing Program reserves the right to require nursing students to demonstrate the ability to meet the above Technical Standards, and/or to provide healthcare provider verification of the ability to meet the Technical Standards upon request.

Nursing Program Options

All nursing program options are Associate of Applied Sciences - Transfer (AAS-T) degrees.

NURSING (RN) - 6-Quarter AAS-T

Student Conduct Rules

Student Conduct: College Policy 5030

Admission to the College carries with it the expectation that students will conduct themselves as responsible members of the academic community. This includes the expectation that students will obey the law; comply with the rules and regulations of the college; maintain high standards of integrity and honesty; respect the rights, privileges, and property of other members of the College community; and will not interfere with College operations (WAC 132G-120-010 to -140). Cheating and plagiarism are considered conduct that violates College rules and that will result in action by the faculty.

Students will assume responsibility for their own conduct. Sanctions for violations of College rules and regulations or for conduct that interferes with legitimate College affairs will be dealt with by the College. In the case of student conduct that involves an alleged or proven violation of criminal law, the disciplinary authority of the College will not be used to duplicate the function of civil authority.

Sanctions, up to and including expulsion from the College, may be imposed for failure to satisfy the expectations stated above or for misconduct of the kinds indicated. These sanctions will determine whether, and under what conditions, the violator may continue at the College.

Nursing student conduct is further governed by the policies of the clinical agencies and the Nursing Program.

Definitions from the College Policy include:

Academic dishonesty occurs when a student provides unauthorized academic benefits to another student or receives academic benefits, he/she did not earn through his/her own efforts by cheating or plagiarizing.

Cheating includes, but is not limited to, conferring an unearned benefit to another student, copying another's work on an exam, preparing for an exam by using test questions from a stolen exam, accessing unauthorized materials, or turning in another's work as one's own.

Plagiarism is quoting, paraphrasing, or summarizing portions of another's work from a published, unpublished, or electronic source without acknowledging that source.

Consequences of any breach of academic integrity shall be clearly defined in a course syllabus and may include withholding of credit, lowering of grade, and/or failure (0.0) for the assignment and/or course, or lesser sanctions. Matters involving academic dishonesty may be referred to the Dean for Student Services for additional disciplinary action(s).

Student Grievance Policy and Procedures

Student Grievance Procedures- Academic Evaluation Policy: College Policy 5035

Students are protected by College policy through orderly procedure against arbitrary or capricious actions or decisions relating to academic evaluations by their instructors. The grievance procedure provides a means of resolving disagreements or misunderstandings regarding the assignment of grades and provides an impartial decision and remedy in cases that cannot be resolved by mutual agreement.

Learning Resources to Support Student Success

Library References

Nursing books available in general circulation (the MAIN collection) are listed in the online catalog, which can be accessed at <u>https://shoreline.libguides.com/home</u>. You do not need a password to search for library materials in the online catalog. You will also find valuable material in periodicals or books on nutrition, physiology, psychology, sociology, biology, and other subjects related to nursing.

Library Indexes

Nursing periodical literature is indexed in the Cumulative Index to Nursing and Allied Health Literature (CINAHL) and is available through EBSCOhost, one of the SCC library's online index services. In addition to CINAHL's article citations and abstracts, students can access citations, abstracts and full-text nursing and medical journal articles through Academic Search Premier (available in EBSCOhost). Access these online index databases through the library home page. Students must use their SCC email account name and password to access these databases from off-campus locations.

In addition to Shoreline's online indexes, Medline is an index provided free through the National Library of Medicine. Access it at <u>http://www.ncbi.nlm.nih.gov/entrez/query</u>. Most Medline entries contain citation and

abstracts only. However, if an article is available in full-text either through Shoreline's EBSCOhost or ProQuest subscriptions, students will be able to connect to the full-text version of the article by using the PDF or HTML link. Users are alerted to the availability of full text through SCC library holdings by a graphic of the SCC logo. If a Medline article is not available full-text online or in print in our library, Shoreline students may order articles through the National Library of Medicine's Loansome Doc document delivery service. It may take several days or even weeks for these documents to arrive, so plan. Students can order up to five articles per quarter at no charge through Loansome Doc. Students will be charged \$10 per article for any additional articles they order. Students may pick up articles ordered through Loansome Doc at the library's circulation desk.

See the reference librarian for help using these or any other appropriate indexes. These will be important for authoring the required papers. Medline and CINAHL searches are also available at some hospital libraries. Check with your instructor whether a particular hospital library is available to the students. Additional useful indexes (such as the Expanded Academic Index) are also available through the King County Library System (KCLS) at http://www.kcls.org. All students are eligible for KCLS cards.

Public Speaking Center

Career Opportunities

- Nursing is the nation's largest healthcare profession, with nearly 4.7 million registered nurses (RNs) nationwide. Of all licensed RNs, 89% are employed in nursing.
- From 2020 to 2022, the percentage of men in nursing increased from 9.4% to 11.2%.
- The federal government projects that more than 203,000 new registered nurse positions will be created each year from 2021-2031.
- Registered Nurses comprise one of the largest segments of the U.S. workforce as a whole and are among the highest paying large occupations. Nearly 55% of RNs worked in general medical and surgical hospitals, with an average salary of \$77,600 per year according to the Bureau of Labor Statistics.
- Nurses comprise the largest component of the healthcare workforce, are the primary providers of hospital patient care, and deliver most of the nation's long-term care.
- Employment of registered nurses is projected to grow by 5% from 2021 to 2031. Growth in the RN workforce will occur for a number of reasons, including an increased emphasis on preventive care; growing rates of chronic conditions, such as diabetes and obesity; and demand for healthcare services from the baby-boom population, as they live longer and more active lives.
- With more than four times as many RNs in the United States as physicians, nursing delivers an extended array of healthcare services, including primary and preventive care by nurse practitioners with specialized education in such areas as pediatrics, family health, women's health, and gerontological care. Nursing's scope also includes services by certified nurse-midwives and nurse anesthetists, as well as care in cardiac, oncology, neonatal, neurological, and obstetric/gynecological nursing and other advanced clinical specialties.
- In 2022, 17.4% of the nation's registered nurses held a master's degree and 2.7% held a doctoral degree as their highest educational preparation. The current demand for master's- and doctorally prepared nurses for advanced practice, clinical specialties, teaching, and research roles far outstrips the supply.

- For international applicants: Educational program must be equivalent to a US approved nursing program

Examination Requirements

- Pass the National Council Licensure Examination (NCLEX-RN)
- Must register with Pearson VUE for exam administration
- Authorization to test (ATT) required before scheduling exam
- Must pass exam within three attempts
